SWINOMISH TRIBAL COURT INSTRUCTION FOR PETITION FOR NON-DOMESTIC VIOLENCE PROTECTION ORDER

To the Petitioner: The Court will need information about how to contact you, so that you may be kept updated on your case. This information is confidential and will not be distributed to anyone without your permission.

WHO MAY FILE A NON-DOMESTIC VIOLENCE PETITION FOR TEMPORARY RESTRAINING ORDER:

- 1. Any person who alleges that he/she has been placed in immediate threat of serious physical harm or violence may file a petition for a temporary restraining order. You must explain to the court any emergency or special reason that the temporary order should be issued before the other party is notified about this case and can come to court to respond.
- 2. You must explain to the court what damages you are likely to suffer that payment of money from the Respondent would not be able to remedy.
- 3. The Petition must be filed with a Summons and Complaint that states the relief that you believe you are likely to receive from the court because of serious misconduct of the Respondent.
- 4. You must file and serve both the Temporary Restraining Order (if granted by the Court) and the Summons and Complaint to the Respondent.
- 5. The Court will set a hearing date if the immediate order is granted. FAILURE TO APPEAR ON THAT DATE COULD RESULT IN YOU BEING ASSESSED COURT COSTS. If the temporary order is not granted, you may still proceed on the complaint. To do this, you must serve all papers on the Respondent. Twenty (20) days after the Respondent has been served with the Summons and Complaint, you may request a preliminary hearing from the Clerk of the Court. If the Respondent fails to Answer or Appear at the preliminary hearing, the Court may grant you the relief you request.
- 6. If both parties appear at the preliminary hearing, the Court may grant temporary relief and will set the matter for trial.
- 7. A person may file a petition for relief on his/her own behalf, and on behalf of any family or household member that is under the age of eighteen (18) years old.

- 1) Petition for Order of Protection.
- 2) Civil Complaint for Permanent Restraining Order.
- 3) Summons.
- 4) Any supporting documentation.
- 5) Temporary Restraining Order (if signed by the Court)
